CLUSTER 1: PEACE AND SECURITY

★1. Ms A Ramolobeng (ANC) to ask the Minister of Correctional Services:

What (a) steps has he taken against the specified officials and all other inmates referred to in a video clip that went viral (details furnished), who were found guilty of similar offences and (b) is his department doing to dispel the offensive narrative to victims of crime and the general public that correctional centres are hotels?

In light of the recent conviction of Mr Julian Aires, the first person who has been prosecuted by the US Department of Justice on charges related to state capture and convicted after being found guilty of bribing SA Airways procurement officials and a former director, Ms Yakhe Kwinana and given that all of the information, evidence and other documents which led to the specified person's conviction have been available to law enforcement agencies in the Republic for years, what (a) are the reasons why the Republic has only managed to unsuccessfully prosecute three persons for state capture to date and (b) steps will her department take to assist the National Prosecuting Authority to ensure that persons implicated in state capture are prosecuted successfully and swiftly?
